- 3) I HEREBY RELEASE, HOLD HA RMLESS AND PROMISE NOT TO SUE <u>RETROTOURS</u>, INC., its officers, owners, directors, employees and agents (collectively "Releases") with respect to any and all bodily injury and/or other loss resulting from my use of the motorcycle whether as a passenger or rider, any motorcycle, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHER WISE DUR1NG ANY aspect associated with riding upon any motorcycle. This release includes claims arising from strict product liability or resulting from any breach of any express or implied warranty by any Releasee's Release. This release does not release any Releasee from any liability caused by the Releasee's intentional misconduct or from any other liability that cannot be effectively released under applicable law.
- 4) I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASES AND EACH OF THEM FROM ANY LOSS, LIABILITY, DAMAGE, OR COST THEY MAY INCUR ARISING OUT OF OR RELATED TO MY OPERATION OR USE OF ANY MOTORCYCLE, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASES OR OTHERWISE.
- 5) If I am the operator of any motorcycle, I agree to personally confirm that all passengers have signed and agreed to the terms of this Release and Waiver, Assumption of Risk and Indemnity Agreement.
- 6) I hereby agree that this agreement shall be binding upon and enforceable against me, my personal representatives, spouses, assigns, heirs and next of kin without limitation.
- 7) I understand and acknowledge that there are no warranties, either express or implied with regard to the motorcycles including, without limitation, the design or condition of the vehicles, the quality or materials or workman ship of the vehicles, the presence of latent or hidden defects, or the merchantability and fitness of the vehicles for a particular purpose.

I have read the Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement.

voluntarily without any inducement assurance or guarantee being made to me and intend my
signature to be a complete and unconditional release of all liability to the greatest extent allowed
